

**Terms and Conditions of Participation**  
**Company Visit - Srithai (Vietnam) Company Limited**  
**March 27-28, 2026**

**Terms and Conditions:**

1. Eligible participants must be shareholders whose names appear in the shareholder register of Srithai Superware Public Company Limited as of the record date for the compilation of the shareholder list on 30 December 2025.
2. The Company has set a maximum of **30 participants** for this activity. Each shareholder is entitled to one (1) participation right only. Participants must be the shareholders themselves; proxy participation or representation by others is not permitted.
3. Corporate shareholders or custodians may appoint one (1) representative to participate, provided that a certified true copy of the company registration document or the custodian business license, duly signed by an authorized signatory, is submitted as supporting evidence for the authorization.
4. Shareholders must register their interest in participating by scanning the QR Code below or clicking [Link](#) and then completing all required information between 9-27 February 2026 only.



5. On 2 March 2026, the Company will conduct a lucky draw for shareholders who are eligible to participate in the company visit.
6. On 4 March 2026, the list of eligible participants will be announced on the Company's website at [www.srithaisuperware.com](http://www.srithaisuperware.com).
7. The Company will contact eligible shareholders by telephone to confirm travel arrangements. If the Company is unable to reach any eligible shareholder within seven (7) days from the announcement date stated in Clause 6, such shareholder shall be deemed to have waived their right, and the Company will then contact the next shareholder on the reserve list.
8. The Company shall be responsible for expenses incurred during the stay and travel within Vietnam, except for the following expenses, which shall be borne by the shareholders:
  - 8.1 One-half of the round-trip airfare per person, amounting to THB 4,000 per person.
  - 8.2 Accommodation expenses amounting to THB 2,000 per person, or THB 3,000 per person in the case of a single room.
  - 8.3 Personal expenses incurred by the shareholders.The Company will facilitate the arrangement and booking of airfare for the shareholders who are granted the participation rights.
9. The Company reserves the right to:
  - Not permit participants to bring accompanying persons.
  - Not permit the transfer of participation rights to others.
  - Not permit participants to change the travel dates, hotels, restaurants, or visiting locations as specified, which will be communicated by the Company at a later date.
  - Modify the travel itinerary as deemed appropriate.
  - Conduct a draw to select replacement participants in the event of a waiver.

- Not permit directors, executives, or employees of the Company to participate.
  - Not provide any refund in the event that a participant cancels the trip after full payment of airfare and/or accommodation has been made, as the Company will have already advanced payment for the airfare and accommodation.
  - In the event that the number of registered participants exceeds the limit set by the Company, reserve participation rights for shareholders who have not previously participated in a visit to Srithai (Vietnam) Company Limited.
  - Cancel, modify, or postpone the company visit as deemed appropriate if the number of eligible participants is fewer than 15 persons.
  - The Company's decision regarding participant selection shall be final.
